Parties agree to sign all documents necessary to transfer ownership of the Equipment from Seller to the Buyer within ten (10) days of signing this purchase agreement.

Buyer shall be liable for all administrative costs relating to the registration of the Equipment onto his/her name and all costs relating to the Roadworthy Certificate.

5. PURCHASE PRICE AND METHOD

The total purchase price to be paid shall be: **\$ 15,800.00** US Dollars.

The purchase price is to be paid through bank transfer.

6. EQUIPMENT BUY BACK GUARANTEE

Dynamo Heavy Equipment 10 Days Buy Back Guarantee enables the Buyer to return the item/s for a full refund of the purchase price if the product/s was not accurately described and represented. Buyer must directly notify **Dynamo Heavy Equipment** in writing within three (3) days of receiving the product but no longer than ten (10) days after sale date to initiate the return process. The return notification should be addressed to the Seller by phone, or registered mail.

The item is covered by a 6-month warranty. The warranty does not cover any physical damage that occurs after the inspection process.

Inspection period begins at 9:00 am, the weekday following the delivery day, as signed and certified by the Buyer on the delivery receipt.

The purchased product must not be put to work or altered, and must not be used more than to verify the condition of the Equipment and not more than 5 hours of use or 60 kilometres from reading at time of sale. In the event of a return, the buyer is NOT responsible for freight and handling charges. In the event of a return, the Seller agrees to refund the buyer, in full, within 24 hours.

If the Buyer decides to return the Equipment, the Seller (**Dynamo Heavy Equipment**), agrees to return the item, covering all the related costs.

7. MISCELLANEOUS PROVISIONS

The Seller (**Dynamo Heavy Equipment**) confirms that he/she is the owner of the product described in Paragraph 3 (Object of Sale), with the right to sell it to the Buyer for the purchase price and method listed in Paragraph 5 (Purchase Price and Method), that are no liens or encumbrances on such product, and certifies that the information provided in this Purchase Agreement is true, accurate, and complete to the best of his/her knowledge.

The Buyer and the Seller (**Dynamo Heavy Equipment**) agree that the product described in Paragraph 3 above shall be sold by the Seller, and purchased by the Buyer, on an "as is" basis and in an "as is" condition, with a 10 Days Buy Back guarantee to the described product. The Buyer accepts all liability for the product as of the date of arrival.
