**NB:** This contract is an agreement between the seller and buyer. This agreement is a legal binding and can be used in court if the Seller Buyer goes against the terms/conditions in this sales contract.

## TERMS:

1) The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/dog parasite free and up to date with inoculations, proper nutrition, which consists of a good quality professional feed given at regular intervals, and fresh water available at times.

- 2) The buyer Promises to provide a safe environment for the dog, and never allow the dog Roam freely without proper fencing or supervision. The sellerstrongly recommends that the puppy/dog be micro- chipped in order to facilitate his return if lost or stolen.
- 3) The seller guarantees this puppy/dog to be of sound health and temperament at the time of this sale. A health record of all shots and/or worming will be provided by the seller. The buyer agrees to take this dog to a licensed veterinarian of their choice within 48 hours for a physical examination. Should this puppy/dog be determined to be ill health, the cause of which the seller is clearly to blame, the dog may upon a signed written diagnosis from said licensed veterinarian, be refund of the purchase price with immediate effect. The seller assumes absolutely no responsibility for fees associated with caring for the puppy/dog. No other guarantee is given.
- 4) The Buyer agrees not to use this animal for breeding and agree to have it spayed/neutered at the age recommended by their veterinarian (usually 6 months to 1 year of age). This dog will be on limited AKC registration. (Optional paragraph if spay/neuter is required)
- 5) If at any time the Buyer can no longer retain possession of this puppy, the seller is to be notified and given first option of resuming full ownership of the dogs in order for the seller to locate this dog a new home. Refunds, if any, will be at the discretion of the Breeder/seller. The dog will be returned with all AKC papers and medical records. Should any circumstances arise that affects the quality of the life of the dog, the breeder/seller is to be informed so that they may participate in determining the future of the dog. The Breeder/Seller reserves the right to approve/prohibit any transfer of this animal to a third party. Under no circumstances will this dog be sold, leased, traded or given to any pet shop, research laboratory, animal shelter or similar facility.
- 6) The buyer, after making the full payment of \$750 U.S. Dollars, will receive ownership of the puppy, thus the seller will then send the puppy to the designated airport in the local vicinity for home delivery. Once the buyer has the puppy, the buyer will send proof to the seller within 24 hours of receiving the puppy and that the puppy is in good health. The purchase price of includes the cost of the air freight and home delivery charges.
- 7) The puppy will come with the following Certificate, 1 year health guarantee, Complete medical record, Crate, Playing toys, Sample Foodstuffs for the first few days and A Puppy kit starter.
